Minutes of the Governing Body Meeting of Govt. Polytechnic, Gajapati held on 04-01-2025 at 12.30 PM at Collectorate, under the Chairmanship the Collector and District Magistrate Gajapati.

- At the outset the Principal welcomed all the members and the esteemed Collector & Dist. Magistrate, Gajapati to the said meeting.
- Review of last Governing Body Meeting: The proceeding of the last Governing Body Meeting had been circulated to all the members and no objection has been received from any member. Hence the proceeding has been confirmed.
- 3. AICTE Affiliation: (AICTE affiliation for the session 2024-25). The Principal appraised that our Institute has got the affiliation from All India Council for Technical Education (AICTE), New Delhi and State Council for Technical Education & Vocational Training (SCTEVT), Odisha for the year 2024-25 with total intake capacity- 210 (Civil-60, Electrical-60, Mechanical -60 & ETC-30).
- 4. Admission status: This year admission status is 100% (Zero Vacancy) (Fresher) and in Lateral Entry (Civil-02, Electrical-09, ETC-03 & Mechanical-06). The Principal conveyed heartiest thank to the District Administration, District Skill & Employment Officer and Dist Education Office for their sincere support to fill up the seats.
- 5. Civil Construction progress: The Institution Buildings has been constructed by the IDCO, Bhubaneswar and transferred to the Books of R&B, Division, Paralakhemundi. Cycle/Motor cycle Stand, Bus shed, Stage for cultural activities, Smart Auditorium, Basket ball play ground, front gate etc are to be constructed inside the campus. A play ground is to be set up in other patch of land of Govt. Polytechnic, Gajapati (Parsurampur) and some staff quarters are to be also constructed in the above said land. The Chairman suggested to Principal put up a letter with a note of the undersigned to Superintending Engineer, R&B Division, Paralahemundi. The Superintending Engineer, R&B shall prepare the estimate and submit the same to Principal, Govt. Polytechnic, Gajapati.

- 6. Fire Safety Certificate: The Principal appraised that it is mandatory to obtain Fire Safety Certificate for getting affiliation from the AICTE, New Delhi. The fire fighting equipments have been installed by the Executive Engineer, R&B Division, Paralakhemundi. The Fire safety certificates for Academic Building has been rejected by the competent authority with due wanting of approval of building from town planning office and RoR in the name of the Institution. Lecturer Stage-I: Eng-01 & Phy-01, Lecturer Stage-II: Civil-02, Elect-01, ETC-01, Mech-01, Math-01, and Chemistry-01, Sr. Lecturer: Elect-01, E&TC-01 & Mech.- 02 are available in our institute. Also Lab Assts in Electrical-01, Mechanical-02, ETC-01 are available. For the current Academic session the engagement of Guest Faculties and Lab Assistants all the Department and Section as follows with due approval of Collector & Dist. Magistrate, Gajapati cum Chairman, Governing Body, Govt. Polytechnic, Gajapati as follows GF: Civil-01, Electrical-02, ETC-02, Mechanical-02, Physics—01 & GLA (Civil)-01 and GLA (Chem.)-01.
- Expenditures incurred towards procurement of Equipment, Library Books, furniture and Repairing of Labs & Equipment.

9. PL Institute Development funds: The Principal appraised that the DTE&T, Odisha, Cuttack is placing the fund towards procurement of new equipment but not placing adequate funds towards repairing of equipment. Only Rs 100/- is being deposited by each student per year under maintenance (Totaling to Rs 30,000/- per year approximately) which is not at all sufficient to meet the expenditures towards maintenance of equipment of different laboratories.

Hence, it is proposed that the Principal may kindly be authorized to spend total of Rs. 3 Lakhs maximum from the PL Development Funds to meet the one time expenditures toward repairing of equipments of Mechanical Engg Lab, Workshop, LAN Connection, CCTV Camera Connection, Civil Engg Lab, Electrical Engg. Lab. and four Nos of Computer Lab, 125 KVA DG Set and Rs 50,000/- Rupees (Fifty thousand) only towards Industrial visit of the students.

The requirement of an internet connection of 50/100 Mbps (ILL) in alternative to BSNL along with firewall system for approximately expenditure of Rs. 7 Lakhs Rupees (Seven Lakhs only) towards installation is recommended. The expenditure for the purpose shall be met out of PL development fund.

The requirement of computerized English Language Laboratory establishment for amounting of Rs. 50. Lakhs (Rupees fifty lakhs) is also recommended. The fund to meet the expenditure shall be from PL Development or DTE&T fund.

The Chairman approved the above mentioned proposals.

10. Outsourcing of Manpower / Support Service: The DTE&T has approved to engage 12 Nos of manpower on out sourcing basis like Two nos for Data Processing Assistant, One for Driving, three for watch & ward, two nos for Cleaning & Sweeping, and four for Attendant works have been engaged on out sourcing basis after renewal for one year. The committee approved the engagement of manpower. The Chairman advised to go for Fresh Tender for engaging manpower through Outsourcing in place of renewal basis.

Action:- The Principal, Govt. Polytechnic, Gajapati.

11. Issue of RoR (Patta) to the Govt. Polytechnic, Gajapati. The Principal appraised that RoR (Patta) has not yet been issued for Govt Polytechnic, Gajapati. The Chairman enquired from the Additional District Magistrate (Revenue) the alienation file will be ready soon and will be to send to the RDC, Berhampur.

Action:- The Deputy Collector, Revenue

12. Any other point for discussion with permission of the Chair.

- A. The Principal informed that the OSCOM IREL has been requested to install Mini Mast Light (05 nos) & Solar Street Lights (15 nos) in the campus under CSR fund.
- B. The Proposal for the Open Gym equipments has been requested to the OSCOM IREL, Chhatrapur from CSR fund.

The Chairman agreed to the proposal and directed the Principal to put up & send the requisition letter along with proceeding under the note of undersigned.
